Dear Your Highness Sheikh Mohamed bin Zayed Al Nahyan [صاحب السمو الشيخ نجم بن زايد آل نحيان],

Scientific integrity is vital to the credibility and dignity of all academic institutions. It would tarnish the reputation of any prestigious university, such as **Mohamed bin Zayed University of Artificial Intelligence** [جامعة عُمَد بن زايد للذكاء الاصطناعي] ("MBZUAI")¹, to employ someone with a history of falsification, fraud, and scientific misconduct.

Recent hires by MBZUAI include an unethical individual—Hao Li, Ph.D.²—who was determined to have committed various violations of the scientific code of conduct. The University of Southern California [جامعة كاليفورنيا الجنوبية] ("USC")³ has conducted a full investigation of Li's scientific misconduct since 2018, the results of which have been summarized in a 490-page report and published online.⁴

Upon examining Li's computers, hard drives, and research software code, USC's investigation committee found that Li committed falsification⁵, intentional misrepresentation⁶, and research misconduct⁷. Moreover, Li attempted to destroy the evidence by deleting research data on his university issued devices.⁸

In addition to not disclosing these findings to MBZUAI, on information and belief, Li has further deceived MBZUAI into offering him an associate professor position through additional misrepresentations:

- Termination of Li's employment from USC was involuntary, contrary to his representations to the press⁹ and on social media¹⁰. According to Dr. **Kristen Grace**—USC's Research Integrity Officer who has also confirmed Li's research misconduct in writing¹¹—termination of Li's employment at USC was not voluntary and Li "did not resign."¹²
- Li was not employed by the University of California Berkeley [جامعة كاليفورنيا في بيركلي] ("UC Berkeley")¹³ and did not hold any official title from the university, contrary to his representations on his resume¹⁴ and social media¹⁵. According to Dr. Trevor Darrell,¹⁶ other than collaborating with UC Berkeley researchers and receiving an informal title from one of the faculties, Li did not hold any official employment or title from the university.¹⁷ In fact, Li's name and informal title were removed from UC Berkeley's website around the time USC report was published online.¹⁸

Falsification and dishonesty have no place in academia and are condemned by Allah. I truly hope that this letter would be a step toward protecting the academic reputation of MBZUAI, safeguarding scientific integrity around the globe, and adherence to the teachings of the Quran and Sharia of Allah.
